### TRAINING REGULATIONS

Dogs must be at least 6 months of age and completed at least 1 obedience class to participate in agility.

1. The first night of class, \_\_\_\_\_, is orientation night and is intended for people and dogs.

### REGISTRATION CHECK-IN IS AS FOLLOWS:

**7:00PM CLASS – 6:30 TO 7:00PM**

**8:00PM CLASS – 7:45 TO 8:00PM**

- A.) Bring proper immunizations (shots) records: DOGS OVER 6 MONTHS MUST HAVE HAD DHL, RABIES AND PARVO VACCINES. (Dogs must have proper immunizations to attend our classes. This is intended to help prevent the spread of communicable diseases).
  - B.) Bring a six-foot leash, leather is recommended. For your convenience we have available six-foot leather leashes for \$10.00 each
  - C.) Your dog must be on a buckle collar (no choke or pinch collars acceptable)
  - D.) Bring a chair, crate and water for both you and your dog.
  - E.) Bring 3 different kinds of treats. Suggestions: Biljack, cheese, hot dogs, chicken, salmon treats, liver, roast beef (treats should be no larger than ¼ inch in size).
2. Only one person may handle the dog during training sessions.
  3. Wear working clothes and flat rubber soled shoes or tennis shoes.
  4. DO NOT bring sick or "in heat" dogs to classes, but do attend yourself.
  5. DO NOT feed your dog the evening of training classes. You are responsible for cleaning up any accidents.
  6. Only one class per session can be made up.
  7. You should be prepared to spend two (2) short training sessions (10-15 minutes) with your dog daily between training sessions.
  8. You will be expected to help with the loading and/or unloading of the equipment used in these classes depending on the number of classes scheduled.
  9. To participate in training classes a young person between ages ten to eighteen must be accompanied by a parent or guardian. PARENT OR GUARDIAN MUST ATTEND EACH CLASS!

**REMINDER:** ALL OUR CLASSES FILL UP QUICKLY AND ARE LIMITED IN SIZE TO 10 STUDENTS PER CLASS. DUE TO THIS DEMAND WE SUGGEST THAT YOUR APPLICATION AND CLASS FEE BE SENT IN ADVANCE TO INSURE YOU'RE RESERVED SPOT.

You will be contacted *ONLY* if the class you are registering for has been filled prior to receiving your registration form in the mail.
